## Agreement for Wedding Photography Coverage

This agreement, entered in to on \_\_\_\_\_ is between Advanced Multimedia Designs, Inc., incorporated in the State of Florida and doing business as Tampa Photo (hereinafter "Tampa Photo") and the undersigned (hereinafter "Client") relating to the wedding of \_\_\_\_\_ that will take place at \_\_\_\_\_ on \_\_\_\_\_ at \_\_\_\_\_ pm.

**SERVICE COVERAGE:** The parties agree that Tampa Photo will furnish the services of a Professional Photographer, for \_\_\_\_\_ hours of consecutive photographic event coverage, starting two hours prior to Ceremony and ending at \_\_\_\_\_. Additional hours of coverage can be added at \$325 per hour, per photographer. Tampa Photo will be the sole professional still Photographer employed for the event. Simultaneous photographic coverage by another professional photographer or any guest, vendor or family member with professional equipment (excluding video) releases Tampa Photo from this agreement and immediately terminates service coverage. (Professional equipment is defined by any camera that has a detachable lens and/or separate flash unit.) Family and friends are welcome to take candid photos at the reception and any situation that is not posed by Tampa Photo. No flash photography will be allowed in situations posed by Tampa Photo. It shall be the Client's responsibility to inform family, guests and other vendors of the above restrictions, and to enforce such restrictions. **Initial that you have read and accept terms:** \_\_\_\_\_

**PAYMENT POLICY and EXPENSES:** A non-refundable, non-transferable 50% retainer fee \_\_\_\_\_ is paid to reserve event coverage for the date and time specified above. The balance due, in the amount of \_\_\_\_\_, which is also non-refundable, shall be paid by the Client 30 days prior to the date of the Wedding/Event, which is \_\_\_\_\_. **Client is responsible for final payment reaching our office by the due date.** In the event that the balance is not paid, on or before the date set forth above, Tampa Photo, at its sole and complete discretion, reserves the right to cancel this agreement, as non-payment of any fees releases Tampa Photo from any and all obligations defined in this agreement. In addition, in the event that Tampa Photo receives any payments which are not timely, there shall be a late fee charge of Fifty Dollars (\$50) in addition to any payment that would be due and owing. All fees paid are non-refundable and non-transferable. In the event that the Wedding is cancelled within three months of the event date, the final balance is due and payable immediately. **Initial that you have read and accept terms:** \_\_\_\_\_

**PRODUCT PRICING:** Pricing is defined on the attached face sheet. Tampa Photo warrants that all prices quoted for professional services, included photographs and albums are valid for a period of three months following the date of the wedding. Orders placed after this period, including final Wedding Albums, are billed at the studio's current pricing, which may be greater.

**ENGAGEMENT SESSION:** Engagement Session appointments are available Tuesday through Thursday from 11:00 am - 7:00 pm. Location Engagement Sessions are only available during the months of November through April. You must arrive and be ready to shoot by your scheduled appointment time. If you are more than 15 minutes late it will be considered a cancellation and you must reschedule. Engagement Sessions will only be rescheduled one time. You must provide 24 hours notice for any cancellation or rescheduling. A separate portrait contract must be signed for all Engagement Sessions.

**MEALS:** Any wedding package booked over four hours requires meal(s) to be provided for photographer(s) and assistant(s). These meals must be pre-arranged with your reception vendor. Most reception facilities offer vendor meals which may or may not be different from guest meals. Vendor meals must be served prior to or while guests are being served so we may continue our photographic coverage immediately after dinner. Reception facility must also provide a table and chairs for meal service. If meal service is not provided during dinner, coverage will end at that time. **Initial that you have read and accept terms:** \_\_\_\_\_

**LIMITATION OF LIABILITY:** While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding event, Tampa Photo's entire liability to Client for any claim, loss, or injury arising from Tampa Photo's performance is limited to a refund to Client of fees paid. The amount of liability cannot

exceed the amount of this contract. Because this is an uncontrolled event, Tampa Photo cannot guarantee delivery of any specifically requested image(s). In the unlikely event of personal illness or other circumstances beyond the control of Tampa Photo, a substitute freelance photographer of high qualifications may be dispatched by Tampa Photo to fulfill the obligations of photography herein contracted.

**ATTORNEY FEES AND COSTS:** Client will be liable for all costs of collection under this contract including all legal fees.

**REVIEW AND SELECTION:** For Artist's Album Collections, the Client (Bride & Groom) will receive a CD Slideshow and Thumbnail Proof Gallery of low-resolution images within approximately 4-5\* weeks. This proofing CD will be mailed to the address on file and will expire after six months. If Online Hosting is included in booked Collection, images will be ready for online viewing and ordering approximately 4-5\* weeks after the event and will be online for 30 days. For Perfect Shot Collections, DVD's of the high res images will be delivered within approximately 4-5\* weeks. (\*Delivery timeframe is dependent on our production schedule.)

**ALBUM ORDERS:** For Artist's Album Collections, Client will have five options to choose from for album layout and design. PDF files of finished album designs will be presented online to client before the album goes to press. Any changes to the album after that point will be billed at \$30 per page. If client has not chosen their album layout option or has not approved final layout within six months of their Wedding date, Tampa Photo reserves the right to create a simple album, using our selection of photos, which will fulfill the terms of this contract. Final albums must be into production within 90 days of the wedding date or additional charges may accrue. All correspondence regarding album production will be handled via email and will be between Tampa Photo and the client (Bride & Groom).

**QUALITY STANDARD, FINAL PRINTS:** All album prints will be color corrected by ourselves and/or our lab. Our quality standard target is measured by five guidelines: 1) highlight details are visible, 2) shadow details are visible, 3) whites are clean with no overall color cast, 4) the image has no overall color bias (this does not apply to color balance for lighting conditions), 5) fleshtones are believable. Because lighting conditions and movement provide constant challenges, we cannot guarantee the quality of any image.

**DELIVERY:** Finished albums are shipped via Fed Ex Ground. Client is responsible for final shipping cost of finished album. Delivery of our Albums is approximately two to three months after final approval of the layout. Due to circumstances beyond our control actual delivery times may vary.

**FEDERAL COPYRIGHT LAWS:** Tampa Photo owns all copyrights for any and all images produced in connection with this agreement, including the exclusive right to reproduce or publicly display such images. Any reproduction of any image produced in connection with this agreement is prohibited without proper photo credit.

**OWNERSHIP OF IMAGES:** While Tampa Photo owns all copyrights, upon delivery of the finished album, Tampa Photo will supply the client with a CD of high resolution images. For Collections that do not include an album, the high resolution CD of images will be delivered within 4-5\* weeks. These images are for Client's private use only and may not be published, displayed or sold by anyone other than Tampa Photo. The parties agree that Tampa Photo may reproduce, publish or exhibit a judicious selection of such photographs as samples of photographic work to be shown to prospective clients, and for instructional or institutional purposes consistent with the highest standards of taste and judgment. Client agrees to hold Tampa Photo harmless against any and all claims arising from any published images.

**CREDIT CARD AUTHORIZATION:** I hereby authorize Tampa Photo to use the credit card number listed on the face sheet when paying for retainers, balances or orders authorized by me. Tampa Photo will refer to this agreement as "Signature on file" \_\_\_\_\_

**DISCLAIMERS:** Tampa Photo is not responsible for lost photo opportunities due to other people's camera, or flash, or the unprofessionalism of any other vendor hired by client, or the lateness of the bride, groom, family members, bridal party members or other principals.

If family members, friends or guests come into our image shooting area, client will have to pay additional retouching fees to have these members removed from final images.

Tampa Photo is not responsible for the lack of coverage due to weather conditions, or schedule complications due to lateness of individuals; rules/regulations of church/synagogue; nor the rendering of decorations of the locations.

Tampa Photo reserves the right to substitute photo materials whenever it deems necessary or advisable or whenever it becomes mandatory due to manufacturer's style, price or color changes.

Due to the fact that Weddings are uncontrolled events, we cannot guarantee any specific photograph or pose. We will, however, attempt to honor special requests.

The act of battery against a Photographer or Assistant, by any friend, family member or guest will immediately terminate service and will release Tampa Photo from any obligation to perform further photographic services at the event. The definition of battery is when a person intentionally touches or strikes another person against their will or intentionally causes bodily harm to another person.

Artwork/airbrushing/photo enhancements are not included and will incur an additional charge.

As with any photographic process, variation in color occurs with images and processing. Specific colors/shades cannot be promised. With album covers and pages, minor imperfections and variations in color/texture do occur. No guarantee is made in terms of exact color or texture.

Missed appointments and appointments that are cancelled without 24 hours notice are subject to an office charge of \$50.00.

Tampa Photo charges a \$35 fee on any and all returned checks.

All verbal contracts or oral agreements are void. This is a binding contract and may only be altered in writing.

This contract is not a "work for hire." Tampa Photo is an independent free contractor.

The client agrees to keep the studio informed of any and all changes of address information of any party to the contract.

There are a total of 4 pages to this agreement. Please initial each page. This is the agreement in full and cannot be amended by any party. This agreement is made, and, in all respects, is to be construed under the laws of the State of Florida and of the United States. The parties agree that any dispute under this agreement will be adjudicated in a State Court located in Tampa, Florida and Client expressly agrees to personal jurisdiction of such court.
