## Agreement for 2010 Summer Special Wedding Photography Coverage

This agreement, entered in to on \_\_\_\_\_ is between Advanced Multimedia Designs, Inc., incorporated in the State of Florida and doing business as Tampa Photo (hereinafter "Tampa Photo") and the undersigned (hereinafter "Client") relating to the wedding of \_\_\_\_\_ that will take place at \_\_\_\_\_ on \_\_\_\_\_ at \_\_\_\_\_ pm.

**BOOKING POLICY:** This Collection includes one Telephone Consultation, prior to booking and a follow-up call, the week of the Wedding, for timeline. Any additional Telephone Calls/Consultations will be billed at \$25 per call. Studio Meetings can be added for \$75 per meeting.

**SERVICE COVERAGE:** The parties agree that Tampa Photo will furnish the services of a professional photographer, for four consecutive hours of coverage. Photo coverage will begin two hours prior to Ceremony Start time and end at \_\_\_\_\_. Full reception coverage is not available with this Collection unless additional hours of coverage are added at \$325 per hour. Tampa Photo will be the sole professional still photographer employed for the event. Simultaneous photographic coverage by another professional photographer or any guest, vendor or family member with professional equipment (excluding video) releases Tampa Photo from this agreement and immediately terminates service coverage. (Professional equipment is defined by any camera that has a detachable lens and/or separate flash unit.) Family and friends are welcome to take candid photos in any situation that is not posed by Tampa Photo. No flash photography will be allowed in situations posed by Tampa Photo. It shall be the Client's responsibility to inform family, guests and other vendors of the above restrictions, and to enforce such restrictions. **Initial that you have read and accept terms:** \_\_\_\_\_

**PAYMENT POLICY and EXPENSES:** Payment in full is required to reserve event coverage for the date and time specified above. All fees paid are non-refundable and non-transferable.

**MEALS:** Any wedding package booked over four hours requires meal(s) to be provided for photographer(s) and assistant(s). These meals must be pre-arranged with your reception vendor. Most reception facilities offer vendor meals which may or may not be different from guest meals. Vendor meals must be served prior to or while guests are being served so we may continue our photographic coverage immediately after dinner. Reception facility must also provide a table and chairs for meal service. If meal service is not provided during dinner, coverage will end at that time. **Initial that you have read and accept terms:** \_\_\_\_\_

**LIMITATION OF LIABILITY:** While every reasonable effort will be made to produce and deliver outstanding photographs of the wedding event, Tampa Photo's entire liability to Client for any claim, loss, or injury arising from Tampa Photo's performance is limited to a refund to Client of fees paid. The amount of liability cannot exceed the amount of this contract. Because this is an uncontrolled event, Tampa Photo cannot guarantee delivery of any specifically requested image(s).

**ATTORNEY FEES AND COSTS:** Client will be liable for all costs of collection under this contract including all legal fees.

**DELIVERY:** The Client (Bride & Groom) will receive a DVD that contains the High Resolution Images (print ready, no watermarks). This DVD will be mailed to the address provided on the Order Form. Turnaround time for DVD delivery is approximately 4-6 weeks from date of the event.

**OWNERSHIP OF IMAGES:** While Tampa Photo owns all copyrights, they are providing Client with a DVD of High Resolution images for their private use only. These images may not be published, displayed or sold by anyone other than Tampa Photo. The parties agree that Tampa Photo may reproduce, publish or exhibit a

judicious selection of such photographs as samples of photographic work to be shown to prospective clients, and for instructional or institutional purposes consistent with the highest standards of taste and judgment. Client agrees to hold Tampa Photo harmless against any and all claims arising from any published images.

**FEDERAL COPYRIGHT LAWS:** Tampa Photo owns all copyrights for any and all images produced in connection with this agreement, including the exclusive right to reproduce or publicly display such images. Any reproduction of any image produced in connection with this agreement is prohibited without proper photo credit.

**DISCLAIMERS:** Tampa Photo is not responsible for lost photo opportunities due to other people's camera, or flash, or the unprofessionalism of any other vendor hired by client, or the lateness of the bride, groom, family members, bridal party members or other principals. If family members, friends or guests come into our image shooting area, client will have to pay additional retouching fees to have these members removed from final images.

Tampa Photo is not responsible for the lack of coverage due to weather conditions, or schedule complications due to lateness of individuals or rules/regulations of church/synagogue.

Due to the fact that Weddings are uncontrolled events, we cannot guarantee any specific photograph or pose. We do not work from "shot lists" but we will attempt to honor special requests.

The act of battery against a Photographer or Assistant, by any friend, family member or guest will immediately terminate service and will release Tampa Photo from any obligation to perform further photographic services at the event. The definition of battery is when a person intentionally touches or strikes another person against their will or intentionally causes bodily harm to another person.

Artwork/airbrushing/photo enhancements are not included and will incur an additional charge.

Tampa Photo charges a \$35 fee on any and all returned checks.

All verbal contracts or oral agreements are void. This is a binding contract and may only be altered in writing.

This contract is not a "work for hire." Tampa Photo is an independent free contractor.

The client agrees to keep the studio informed of any and all changes of address information of any party to the contract.

There are a total of three (3) pages to this agreement. Please initial where indicated. This is the agreement in full and cannot be amended by any party. This agreement is made, and, in all respects, is to be construed under the laws of the State of Florida and of the United States. The parties agree that any dispute under this agreement will be adjudicated in a State Court located in Tampa, Florida and Client expressly agrees to personal jurisdiction of such court.
